Her business speaks domestically here in the USA and internationally on matters regarding women entrepreneurship, leadership, economic advantages, and advancement. Her international business continues to contribute tremendously to the advancement of several communities where the natural products utilized in her business originated from; and Attorney Simone Williams, an Attorney, Founder & Managing Partner of Williams Global Law that represents international businesses/investors in matters relating to U.S./global immigration, EB-5




